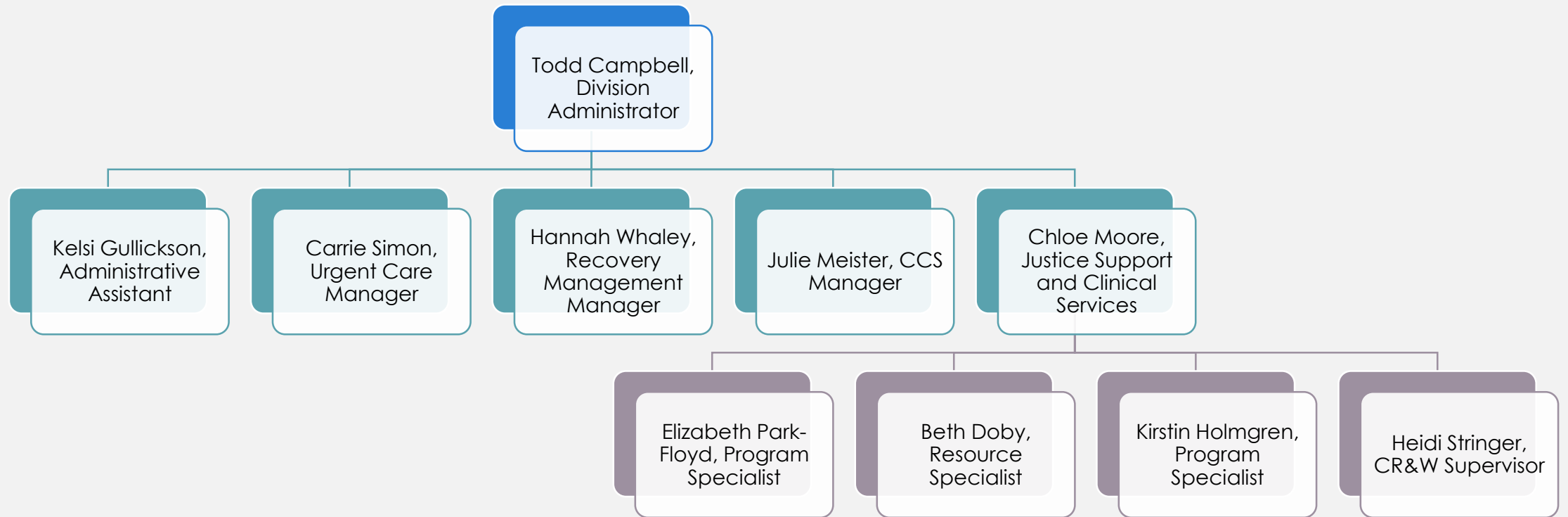

ForwardHealth RSUD Benefit

-
- ForwardHealth RSUD benefit went into effect 2/1/2021 ([Memo](#))
 - Coverage includes all **treatment** services provided at a facility certified under Wis. Admin. Code ch. DHS 75, such as assessment, treatment planning, therapy services, and psychiatric services
 - Coverage does not include Room and Board

DCDHS RSUD Provider Network

-
- DCDHS is able to cover Room and Board costs for MA enrolled Dane County residents at any of our contracted agencies.
 - Contracted agencies are listed in our RSUD Provider Network [Directory](#).
 - DCDHS is only able to fund Room and Board with contracted agencies. Individuals eligible for funding who obtain placement at a non-contracted agency will be responsible for payment of room and board fees.

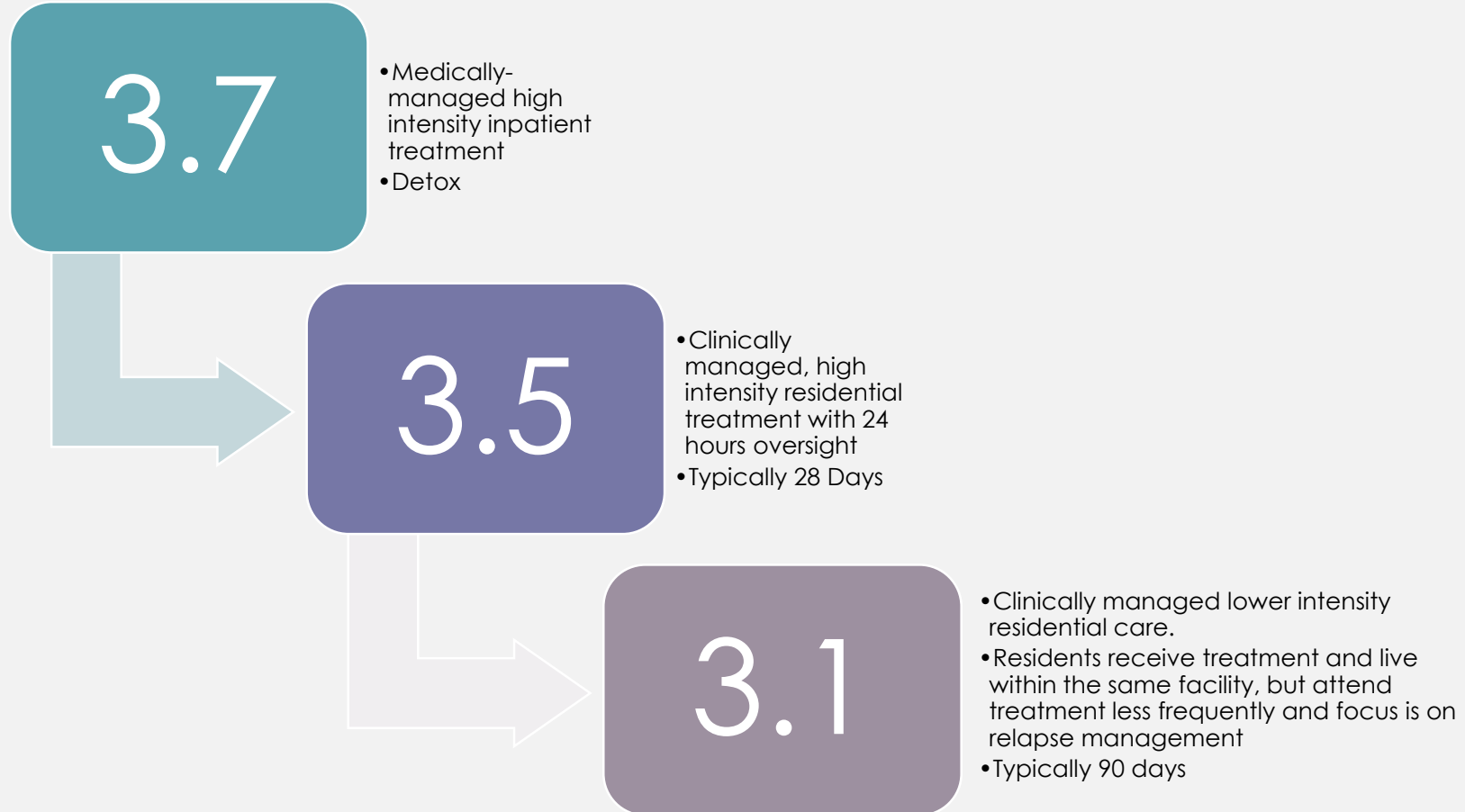

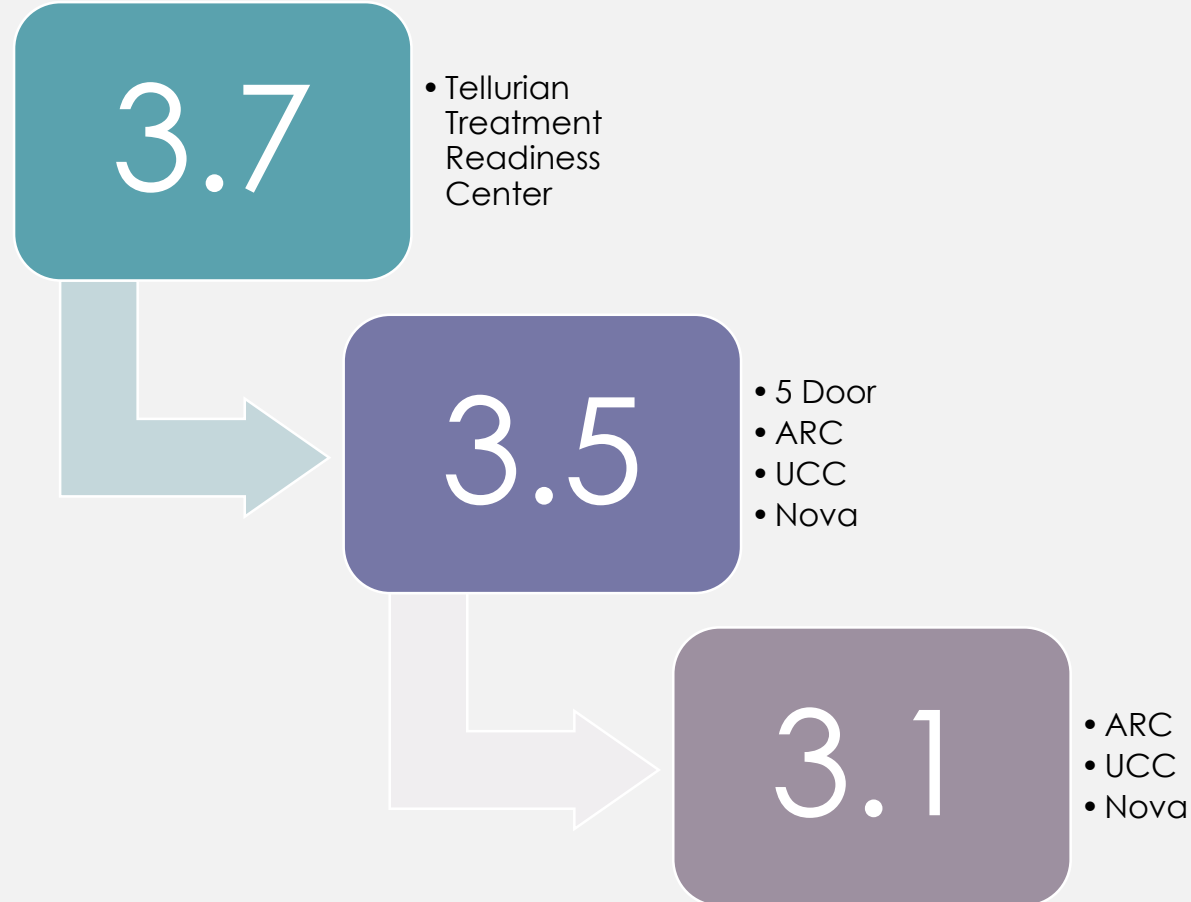
American Society of Addiction Medicine Criteria

-
- ASAM assessments are used to determine the appropriate level of care across the SUD treatment spectrum
 - Spectrum ranges from early intervention and outpatient services through inpatient treatment
 - ForwardHealth requires an ASAM assessment performed by licensed clinician for service authorization

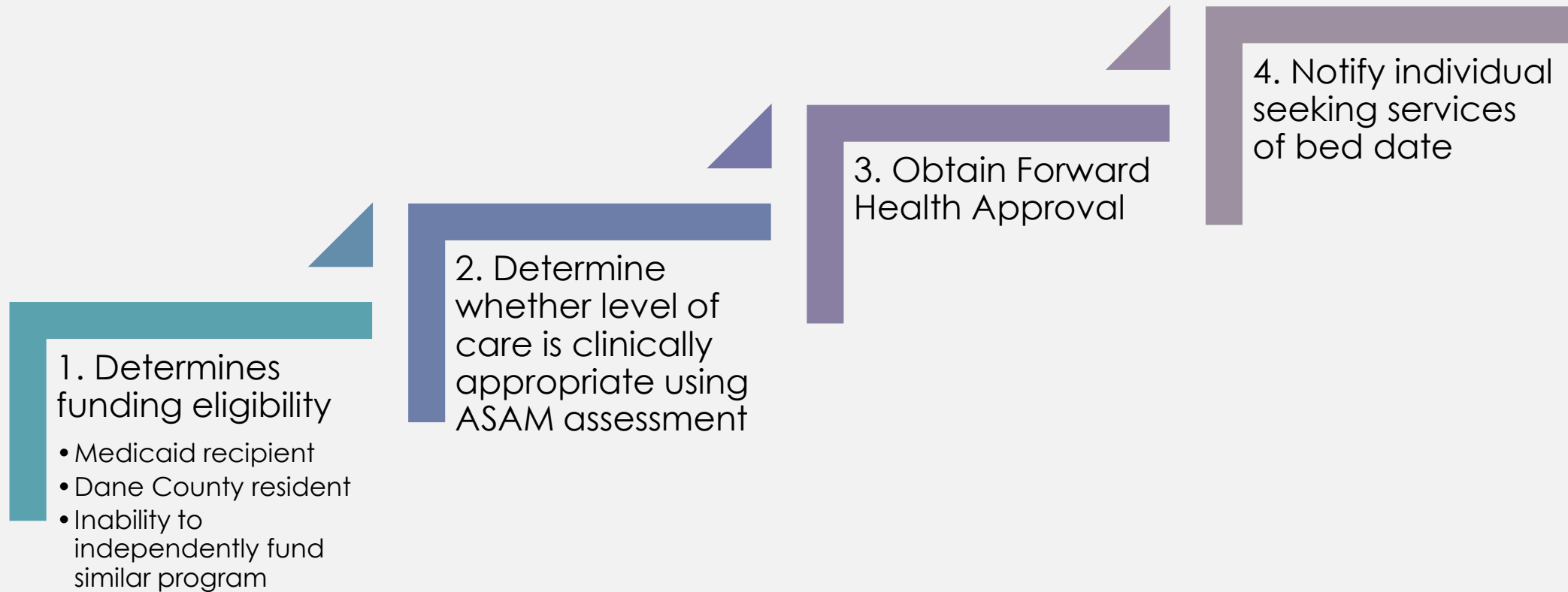
ASAM Levels of Care

Admission Process Used by Contracted RSUD Providers



Process for Individuals with Established Outpatient Providers

Individual seeking services contacts outpatient provider (OP) to request an ASAM assessment to determine appropriate level of care

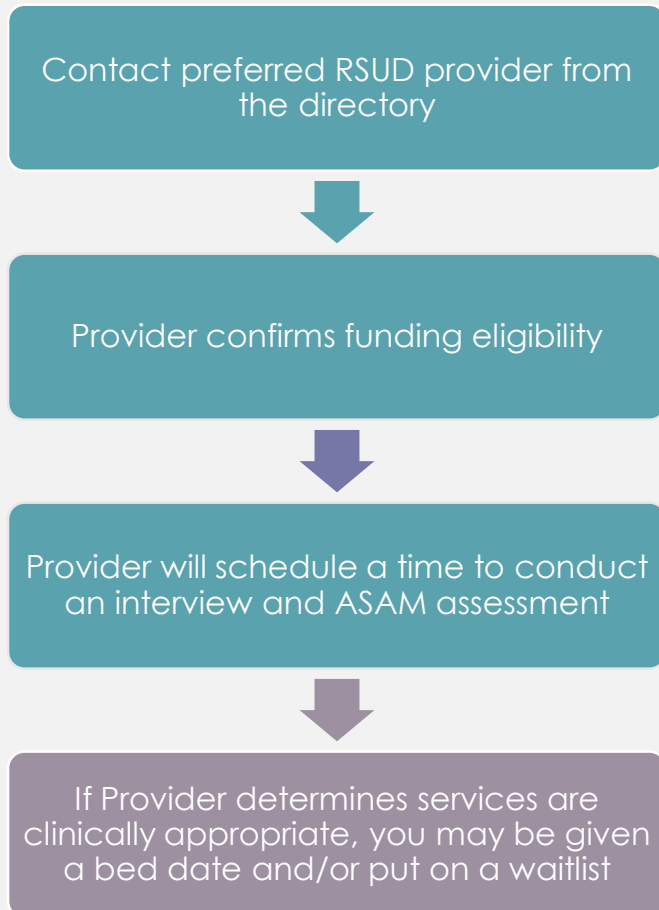
OP Provider supports the individual in identifying their preferred RSUD provider from directory that offers the assessed level of care

OP Provider and/or the individual contact RSUD provider to initiate referral- the process may vary according to RSUD Provider

OP Provider sends ASAM, releases of information, and other records to RSUD Provider

Warm-handoffs between current provider and residential provider is best practice and strongly encouraged, but not required if barriers present

Process for Individuals with no Established Outpatient Provider



- If you are not sure whether you need outpatient (i.e., community-based) or residential treatment, contact the BHRC for help getting connected to an outpatient provider who can conduct an ASAM

Residential Treatment vs. Sober Living

Residential Treatment

- Clinically Managed
- Residents receive treatment and live in the same place
- Facilities are credentialed under DHS 75
- Treatment covered by insurance

Sober Living

- Not clinically managed
- May require checking in with an offsite treatment provider or attending a certain number of meetings per week
- Focus is on recovery and providing safety and structure to build life outside of treatment
- Not required to be credentialed by the state
- Not covered by insurance

- Do not need to have pre-authorization from DCDHS for R&B funding at contracted facility
 - If you are not accepted by any contracted providers AND have been assessed as needing residential level of care, or if waitlists exceed 30 days, contact rsudrequests@countyofdane.com

Tellurian Treatment Readiness Center

-
- Treatment Readiness Center (TRC) is a 3.7 LOC facility providing medically monitored withdrawal management services
 - If an RSUD provider determines that withdrawal management services are needed prior to admission, they will connect with TRC/DCDHS staff to coordinate admission and funding

Dane County Care Center

-
- Dane County Care Center DCCC provides mental health stabilization services
 - If an RSUD provider determines that mental health stabilization is needed prior to admission, they will coordinate with DCDHS staff for admission and funding

Aftercare Planning

-
- DCDHS Behavioral Health Resource Specialist works with contracted providers to assist in aftercare planning for individuals transitioning out of residential care
 - Potential aftercare referrals include case management services, outpatient services, and sober living
 - While the Resource Specialist does weekly utilization review meetings with RSUD providers to discuss aftercare planning, individuals are not required to work with the Resource Specialist to receive funding

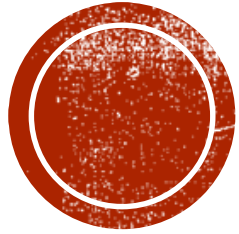

UNIQUE ASPECTS

- **Residential Treatment:** 1 of 2 that has the capability to accept pregnant, postpartum, mothers with their children into treatment (up to 10 years old)
- **Continuum of Care:** Only program within Milwaukee County CARS system to provide a complete Continuum of Care for both men and women,
- **Cultural and linguistic appropriate services:** Bilingual and/or bicultural staff
- **Access:** Only treatment site that serves as an Access Point for Milwaukee County's public sector substance use services delivery system
- **Primary Healthcare:** Only community-based treatment facility that has a collaborative engagement with a Federally Qualified Health Center (Sixteenth Street Community Health Center)
- **Recovery Support Services and Case Management:** service coordination is provided

UNIQUE ASPECTS

(CONT.)

- **CPS visits:** Support and assist re: child visits (around 20-hour Medicaid-required treatment program)
- **Family Services:** Able to serve families in treatment - i.e., mom is in residential treatment and father (father figure) in treatment at UCC as well.
- **Supports Fathers:**
 - Encourage male clients to apply for FDTC
 - Provide support and scheduled child visit for fathers
 - Childcare for fathers (Day Treatment, Outpatient)
- AA meetings onsite (Residential Treatment)
- 1-year free gym membership (César Pabón Fitness Center): Only treatment site that provides this incentive (completed residential treatment)

Cradle-to-Grave services: embedded in a community center setting that provides a variety of other services that support individuals & families

MORE ABOUT OUR RESIDENTIAL PROGRAM

- **Capacity: 16 Male Beds 30 Female Beds**
- **What is Included:**
 - **Referrals To Primary Health Care Provider**
 - Collaborative partnership with Sixteenth Street Community Health Center
 - **Orientation and education on Medication Assisted Treatment (MAT)**
 - Onsite MAT prescription/services for Buprenorphine (i.e., Suboxone) and Naltrexone (i.e., Vivitrol)
 - Referrals are made as needed/appropriate (client choice) as clients transfer to lower Level of Care
 - Ongoing monitoring and oversight and service coordination with prescribers
 - Coordination with Methadone provider
 - *CleanSlate* (MAT provider) onsite co-location
 - **Prenatal Care Coordination**
 - **Ongoing appointments with UCC APNP**

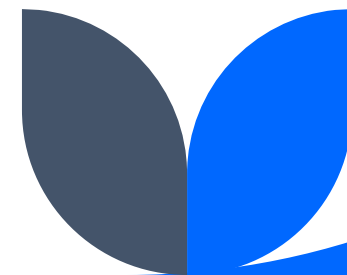

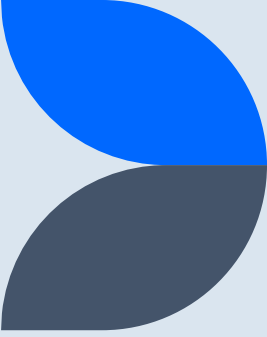


Admission Criteria

- **Must be 18 years or older**
- **Not under the influence of alcohol, illegal, or prohibited drugs**
- **Primary diagnosis of Substance Use Disorder as described in DSM-5-TR**
- **Ambulatory and can complete activities of daily living**
- **Mentally and physically able to respond to a fire alarm and exit the building within 2 minutes**
- **Medically stable (not in active acute withdrawal)**
- **Psychiatrically stable**
- **Applicants must have the cognitive ability to understand and benefit from treatment**
- **No applicant will be denied or discriminated against based on race, sex, color, creed, sexual orientation, handicap, age, religion**

Applicants with a criminal history of sexual assault, extensive history of violence against people or animals, or abuse of a child may be excluded from admission

- 90-day transitional program (3.1 level of care)
 - 8 beds available
- We accept Forward Health along with most commercial insurance plans
- We also offer reasonable self-pay options
- Tobacco-free campus
- Licensed and certified for substance use disorder treatment only; not a dual diagnosis facility
- Considered a medically-monitored facility (we do not have doctors or nurses on staff)

Helpful items to have when making a referral:

- ASAM with recent AODA assessment or psychological evaluation, if available
- History and physical, or any notes from medical stay
- Current medication list
- If on MAT, client should contact provider or home clinic to make arrangements for treatment and guest dosing in Oshkosh, if needed

Exclusionary information

- Someone who has a diagnosis of major mental illness or a mental health diagnosis that is considered primary, including chronic suicidal ideation
- Registered sex offenders
- Someone who has been convicted of a violent crime against a minor (does not include neglect)
- Someone who is not considered ambulatory or semi-ambulatory (no wheelchairs)
- Certain medications, such as opiate painkillers or controlled substances for sleep

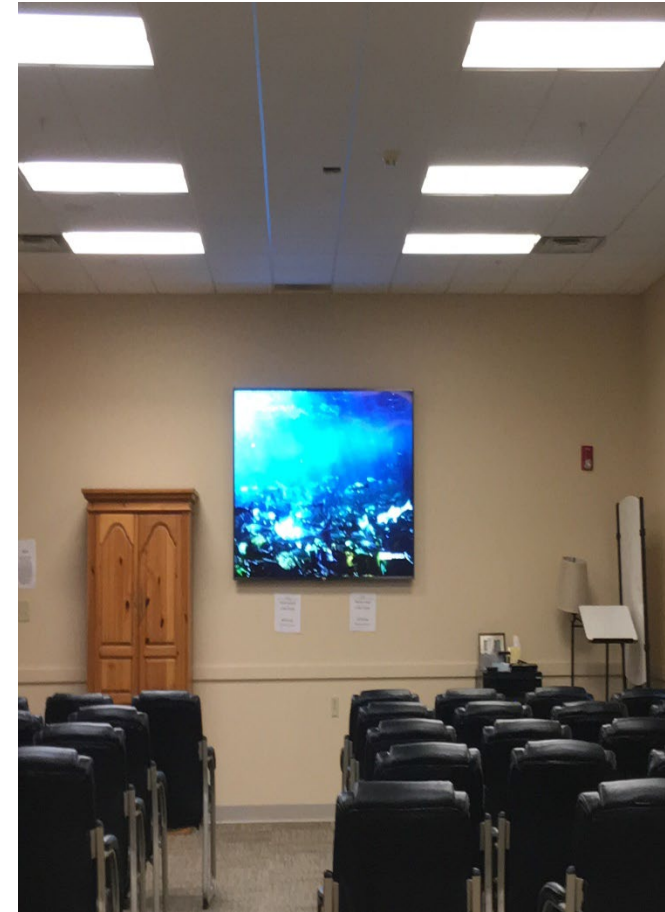

- A safe, structured living environment utilizing trauma informed principles
- Strength-based Gender responsive treatment & case management

ARC Medicaid guidelines:

- **Must meet the level of care offered by the program**
- **No history of excessive violence**
- **Mental health must be stable enough to utilize treatment**
- **Must be a voluntary placement i.e. client states they want treatment**
- **3 missed contacts (agreed upon telephone calls or check-ins) and they go to the bottom of the waitlist**
- **A year between treatment placements**
- **TB skin test results required (less than 90 days old)**
- **Must agree to detoxification if this is the medical recommendation**
- **Clients dosing daily with methadone must be vaccinated for COVID**
